ORDER:

Government, after due consideration of certain representations received from the aspiring candidates, the Covid pandemic situation prevalent during the last two years and the new Presidential Order, 2018 providing 95% reservation in favour of local candidates for the first time, have decided to raise the maximum age limit as prescribed in the special or adhoc rules for appointment by direct recruitment to various services/ categories of posts of uniformed services in the Police, Fire, Prisons, SPF, Excise, Transport and Forest departments by further two (2) years in addition to the raise of three (3) years notified in the G.O.3rd read above.

2. Accordingly, the following notification will be published in the Telangana Gazette:

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Government of Telangana hereby makes the following Adhoc rule, namely:-

ADHOC RULE

Notwithstanding anything contained in the Special or Adhoc Rules in respect of various services/ categories of posts of uniformed services in Police, Fire, Prisons, Special Protection Force, Excise, Transport and Forest Departments, the maximum age limit as prescribed in the said Special or Adhoc rules for appointment by direct recruitment shall be raised by further two (2) years, in addition to the raise of three (3) years already notified in the adhoc rule issued vide G.O.Ms.No.48, General Administration (Ser.A) Department, dated:13.04.2022, i.e., by total of five (5) years.

This relaxation will be applicable for a period of two years from the date of issue of this adhoc rule.
